24/7 Access--Individual Member Agreement, Release, and Waiver

- The 24/7 access option is available only to Long Branch Area YMCA members in good standing who are age 21 and older. No one under 21 is allowed 24/7 access.
- The 24/7 access option is an additional \$10 per month per membership unit. This includes 24/7 access for all members in the unit age 21 and older. (Financial assistance does not apply to 24/7 access.)
- 24/7 access cards are \$5 per individual, as a one-time charge or for a replacement card.
- Local law enforcement officers who are LBA-YMCA members will receive the 24/7 access option at no additional charge, to increase law enforcement traffic after hours: MSHP Troopers; City of Macon Police Officers; Macon County Sheriff Deputies.

Facility Access includes: Fitness Center, Gym, Track, Lobby Restrooms, Elevator, **Telephone for 911 only**, multipurpose room and meeting/spin room (locker rooms, downstairs rest rooms, and child watch are not accessible). **Initial _____**

Safety and Security: YMCA Staff are not present for 24/7 access. YMCA Staff are present during regular business hours. Therefore, the YMCA has installed a 24-hour video camera recording system for security purposes. Please note that this system will not protect you from harm in or on the building premises. Please use caution when entering and leaving the building. **Initial _____**

Parking lot and sidewalk snow removal and application of ice melt will not be completed until staffed hours of operation. 24/7 access members utilize the YMCA at their own risk from the elements. **Initial _____**

Interior lights will remain on around the track, in addition to security lighting throughout the facility. Motion detector lights will automatically control interior lighting. **Initial _____**

Scan Cards: Each individual with 24/7 access will be required to have their own scan card for entry into the YMCA during non-business hours. Family members age 21 and over must scan individually with their own card. **Initial _____**

Each individual must scan in as a separate entry. Multiple entrees (24/7 members or non-24/7 members) on the same scan card will be regarded as a theft of membership and will result in termination of all parties involved. **Initial _____**

In order for YMCA staff to properly close the Y facility each evening, 24/7 access members in the Y at the time of close will have to completely exit the front door of the facility and re-enter with their scan card. **Initial _____**

4. I will not allow or bring anyone into the YMCA facility outside of staffed hours. **Initial** _____
5. I will enter and exit through the front door of the YMCA facility ONLY. **Initial** _____
6. I will not open any windows or open or prop any exterior doors while in the YMCA. **Initial** _____
7. I accept full responsibility for all my personal property brought onto the premises or into the Y facility. I understand that the Y is not responsible for any items that are lost or stolen. **Initial** _____
8. I will wear appropriate exercise attire, including shirt, short/pants and clean athletic shoes. **Initial** _____
9. I will practice proper safety techniques when using equipment and exercising. I will not drop, throw, or bang weights. **Initial** _____
10. I will spray, wipe down, and put away all equipment when I am finished. **Initial** _____
11. I will not smoke or bring or consume alcohol on the premises. **Initial** _____
12. I will not bring or consume food in the facility. **Initial** _____
13. I will not behave with verbal or physical abuse toward others, swearing or foul language. **Initial** _____
14. I will not bring personal stereo into the facility. I understand that personal devices used with headphones are allowed and a radio is provided in the Fitness Center. **Initial** _____
15. I will not use the YMCA telephone, except in emergency situations to dial 911. **Initial** _____
16. I will report any injury (major or minor) to YMCA Full-Time Staff. **Initial** _____
17. I will report any equipment or facility damage or repair needed to YMCA Full-Time Staff. **Initial** _____
18. I understand 24/7 access is in conjunction with each member's Membership Contract and Welcome Letter agreement. Thirty (30) days advance notice is required to cancel my membership or 24/7 access. **Initial** _____
